**Resolution for Maintenance of Streets and Highways**  
**by the Village of Gilberts, County of Kane, Illinois**  
**Under the Illinois Highway Code**

**BE IT RESOLVED** by the President and Board of Trustees of the Village of Gilberts, Kane County, Illinois that:

**Section 1.**

The Village of Gilberts hereby appropriates the sum of \$16,094.18 of Motor Fuel Tax funds for the purpose of maintaining streets and highways under the applicable provisions of the Illinois Highway Code from May 1, 2016 to April 30, 2017, as follows:

An amount not to exceed \$30,119.35 shall be appropriated for snow & ice removal, as described in the form hereto attached as Exhibit "A".

**Section 2.**

**BE IT FURTHER RESOLVED**, that only those streets, highways, and operations as listed and described on the approved Municipal Estimate of Maintenance Costs, including supplemental or revised estimates approved in connection with this Resolution, are eligible for maintenance with Motor Fuel Tax funds during the period as specified above.

**Section 3.**

**BE IT FURTHER RESOLVED**, that the Clerk shall, as soon as practicable after the close of the period as given above, submit to the Department of Transportation, on forms furnished by said Department, a certified statement showing expenditures from and balances remaining in the account(s) for this period; and

**Section 4.**

**BE IT FURTHER RESOLVED**, that the Clerk shall immediately transmit two certified copies of this Resolution as attached hereto and made part hereof as exhibit "A" to the district office of the Department of Transportation, at Schaumburg, Illinois.

**Section 5.**

This Resolution shall be in full force and effect from and after passage and approved in accordance with law.
