The meeting was called to order at 7:00 pm.

**Roll Call/Establish Quorum**

**Approval of Minutes**

Vice Chair Davidowski asked for clarification of the sixth paragraph on page 5, to which Commissioner Sullivan explained to her.

**A motion was made by Vice Chair Davidowski and seconded by Commissioner McHone to approve the minutes of April 13, 2016.** Vote: 2-ayes (Commissioners McHone and Sullivan). 0-nay, 2- abstain (Vice Chair Davidowski and Chairman Mills). Motion carried.

**Community Unit School District 300-Special Use Petition-Gilberts Elementary School, 729 Paperbark Lane, Gilberts, IL 60136**

**A motion was made by Commissioner Sullivan and seconded by Vice Chair Davidowski to open the public hearing at 7:04 pm.** Vote: 4 ayes (Commissioners McHone and Sullivan, Vice Chair Davidowski and Chairman Mills). 0-nay. 0-abstain. Motion carried.

Commissioner Borgardt arrived at 7:04 pm and recused himself from the public hearing portion of the meeting.

Mr. Bob Borgardt, representing the Gilberts Grizzlies, explained how the lights are currently installed on the scoreboard which is located on the football field at Gilberts Elementary School. They illuminate 30 yards behind the scoreboard as well as 30 yards in front of the scoreboard. The lights enable the football teams to practice in the evening and are not utilized for games. The lights would not go on before 5:30 pm and would not be utilized after 8:30 pm due to the practices occurring on school nights.

Vice Chair Davidowski inquired whether the Village had received any complaints or comments after the public notice went out. The Village did not receive any responses. There was no one in the audience opposed to the lighting either.

**A motion was made by Vice Chair Davidowski and seconded by Commissioner Sullivan to close the public hearing at 7:13 pm.** Vote: 4 ayes (Commissioners McHone and Sullivan, Vice Chair Davidowski and Chairman Mills). 0-nay. 0-abstain. Motion carried.

**A motion was made by Commissioner Sullivan and seconded by Commissioner McHone to recommend approval to the Village Board for a special use to allow Community Unit School District 300 to place lights on the Gilberts Grizzlies' scoreboard.** Vote: 4 ayes (Commissioners McHone and Sullivan, Vice Chair Davidowski and Chairman Mills). 0-nay. 0-abstain. Motion carried.
